Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), the partnership of **NEAL ROBERT CAVE AND SUZANNA MICHELLE TAYLOR** (the licensee) is authorised to sell alcohol on the premises situated at 419 Omarunui Road, Hastings and known as Alchemy Wines, to any person for consumption off the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Endorsement

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

CONDITIONS

This licence is subject to the following conditions:

- a. A remote sale of alcohol can be made at any time on anyday.
- b. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day.
- c. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made:
 - i. on the premises; or
 - ii. from grapes or fruit harvested from land on which the premises are situated
- d. The holder of a remote sellers licence must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.
- e. The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
- f. The holder of this licence must display on the website, in a prominent place, the alcohol licence number, expiry date and a copy of the licence for the premises.
- g. The licensed area is described on the plan date stamped: 28 May 2019.

<u>Duration</u>

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force:

- a) either:
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either:
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
